Dear Mr. Hur:

I am writing to bring to your attention a potential criminal violation of public trust committed by Maryland Transportation Secretary Pete Rahn and Governor Larry Hogan.

On April 13, the *Maryland Daily Record* reported that Maryland Transportation Secretary Pete Rahn's former employer, HNTB Corporation, was recommended for a nearly \$70 million state contract and Rahn personally waived the Maryland Department of Transportation's (MDOT) procurement process—condensing an 18-24-month process into less than two weeks<sup>1</sup>.

On April 16, the *Daily Record* reported that Secretary Rahn had a "private dinner" with a former HNTB colleague, then attempted to cover his tracks by obtaining a waiver form the Maryland State Board of Ethics after a decision had already been reached to recommend HNTB for the contract.<sup>2</sup>

Research conducted by the Maryland Democratic Party found that Governor Hogan, the Maryland Republican Party and the Republican Governors Association have accepted more than \$100,000 in donations from HNTB Corporation. Governor Hogan's refusal to voluntarily release all communications between his administration and HNTB violates the public trust and points to an effort to conceal potentially illegal actions.<sup>3</sup>

Public service is a public trust, and there is evidence showing that Governor Hogan and Secretary Rahn violated that trust.
